Eligibility /Qualification Criteria

All bidders must enclose :

- (i) GST registration/service tax registration/Income tax certificate along with the tender document.
- (ii) Registration with Ministry of Environment and Forest/Central Pollution Control
- (iii) Board/Odisha State Pollution Control Board/ any other state pollution control board etc. regarding disposal of e-waste.

Period of validity of Bid:

The bid shall remain valid for 180 days after the date of bid opening.

General Terms and Conditions:

- (i) GST rate as applicable at the time of auction shall be charged extra.
- (ii) Each page of tender document should be signed by the bidder(s) in token of acceptance of terms and conditions of tender.
- (iii) Incomplete and unsigned quotations are liable to be rejected.
- (iv) Tender Form attached with this Tender Notice as Annexure 'A'.
- (v) Check List of Bidders to be submitted along with Bid as mentioned in Annexure 'B'
- (vi) Details of obsolete items are as per Annexure 'C'.
- (vii) The bidders may inspect the items on predetermined dates and satisfy themselves about the items they are bidding for.
- (viii) The items shall be sold to the **highest (H 1)** price of bidder.
- (ix) **The price quoted by the bidder will be valid for 180 days. Bank may give repeat order within 180 days.**
- (x) No items, once disposed to the successful bidder, shall be taken back by OGB.

- (xi) The successful bidder has to make full payment in the form of Demand Draft of any Nationalized/Schedule Bank drawn in favour of “Odisha Gramya Bank” payable at “Bhubaneswar” within seven (7) days of confirmation and receipt of GST compliance proforma invoice from OGB , failing which the offer may be cancelled.
- (xii) The successful bidder shall be required to lift all the items from the disposal site to his premises within 7 (seven) days after the payment of the quoted amount. On failure to do so, OGB shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder.
- (xiii) Final decision to accept/reject the bids shall be taken by the Purchase/Auction Committee, OGB.

6. Bidding Procedure:

- (i) Bid shall be submitted in the prescribed format in a sealed envelope.
- (ii) Sealed Bids shall be received, not later than 20th September 2019 at 04:00 PM. No Bid will be accepted after this date and time under any circumstances. The office will not be responsible for any postal/courier delay and also for reasons beyond the control of this office.
- (iii) All bids must be delivered in the office of Odisha Gramya Bank, Head Office, At-Gandamunda, P.O.- Khandagiri, Bhubaneswar-751030
- (iv) All relevant rules and regulations of Government of India will be final and applicable & binding on all bidders.

7. Submission of Bids:

- (i) The bid should be submitted in the prescribed bid format given as prescribed in “Bidding Procedure” of this document. All columns of the bid form should be filled.
- (ii) No bid may be modified subsequent to the deadline for submission.

8. Opening of Bids:

- (i) OGB will open the bids after scheduled time, date and venue in the presence of the bidders' representatives who choose to attend.
- (ii) The bidders' representatives who will be present shall sign in the designated register evidencing their attendance.
- (iii) The bidders' names, bid withdrawals, presence of bid security and such other details as the OGB at his discretion may consider appropriate will be announced at the time of bid opening.
- (iv) Obsolete Items are mentioned in Annexure 'C'

H1 will be selected on as a whole for all categories of item mentioned above.
Bidders have to quote total price for all items as per Annexure 'A'.
