No. 1 & 3, Rs.20,000/- (Rupees Twenty Thousand only) for Sl. No. 2 and Rs.40,000/- (Rupees Forty Thousand only) for Sl. No. 4.**
- The property shall be sold to the highest bidder. The successful bidder (purchaser) shall have to deposit 25% of the sale price (less the EMD) immediately on the sale being confirmed in his/her favour and the balance amount of sale price within 15 days from the date of confirmation of auction sale.
